GARIS PANDUAN RAYUAN UNTUK
PELANJUTAN TEMP OH MAKSIMUM PENCALONAN
GUIDELINES TO EXTEND MAXIMUM
PERIOD OF CANDIDATURE

1. Rayuan untuk pelanjutan tempoh maksimum pencalonan perlu dibuat pada maksimum pencalonan semester terakhir sebelum tamat tempoh pencalonan maksimum.
Appeal to extend the maximum period of candidature need to be submitted the final semester before the end of the candidature period.
2. Rayuan perlu dibuat dengan menggunakan Borang Rayuan Untuk Perlanjutan Tempoh Maksimum Pencalonan yang boleh diperolehi dari Fakulti/Akademi/Pusat/Institut atau laman web IPS (<http://www.ips.um.edu.my>)
Appeals need to be made on the Appeal Form To Extend The Maximum Period of Candidature obtainable from the Faculty/Academy/Centre/Institute or website IPS (<http://www.ips.um.edu.my>).
3. Calon perlu mengemukakan permohonan lengkap melalui Penyelia (bagi calon secara penyelidikan) atau Timbalan Dekan/Pengarah (Ijazah Tinggi) (bagi calon secara kursus) dan Dekan/Pengarah untuk kelulusan Seksyen Kemasukan, Institut Pengajian Siswazah.
The candidate is required to submit the complete application through the Supervisor (for those following research programmes) or the support of the Deputy Dean/Director (Higher Degree) (for those following coursework programmes) and the Dean/Director for approval of the Admission Section, Institute of Graduate Studies.
4. Kelulusan pelanjutan boleh diberikan sebanyak dua (2) kali sahaja satu (1) semester untuk satu (1) kali permohonan)
Approval for extension of one (1) semester can be given to the candidate not more than two (2) times.
5. Sebarang rayuan untuk melanjutkan tempoh selepas pelanjutan dua (2) semester diberi, tidak akan dipertimbangkan.
Any further appeal after an extension of two (2) semesters has been given, will not be considered.
6. Calon yang rayuannya diluluskan perlu menguruskan pendaftaran dalam tempoh sebulan dari tarikh surat kelulusan.
Candidates whose appeal is approved are required to re-register within one (1) months from the approval date.
